General

Question 1: Should I get the flu shot?

Answer: According to the Centers for Disease Control and Prevention (CDC), the single best way to prevent the flu is to get vaccinated (see more at www.cdc.gov/flu). Talk with your health care provider to determine if getting a flu shot is right for you. All employees are reminded to stay home if they feel sick.

Question 2: Where can I get a flu shot this year?

Answer: Employees and their families who wish to get a flu shot may visit a network retail pharmacy or a health care provider as early as mid/late August. Onsite flu shots at Boeing sites have been cancelled in support of efforts to reduce expenditures across the enterprise.

Question 3: Are flu shots available for non-U.S. employees?

Answer: Flu shots are handled differently outside the United States. Boeing and fully integrated subsidiary employees are encouraged to reach out to their health care provider or check with Human Resources for details about any local flu vaccination options.

Retail Flu Vaccine

Question 4: Who is eligible to receive a flu vaccine at no individual out-of-pocket cost at a network retail pharmacy setting?

Answer: Active employees and their covered dependents and pre/post-age 65 retirees and their dependents who are enrolled in one of the following Boeing-sponsored medical plan options are encouraged to get a flu shot at a Prime Therapeutics network pharmacy:

- Blue Cross and Blue Shield of Illinois (BCBSIL) plans (Advantage+, Traditional, Select Network, Selections, Selections Plus and Preferred Partnership options)
- Cigna HMO
- Banner | Aetna HMO (excluding Aetna HMO in Kansas)

To locate an in-network pharmacy, go to the Total Rewards Portal> My Health & Insurance Coverage> Prescription Drugs> Prime Therapeutics, scroll down the page, and select "Find a Pharmacy."

If covered under a Boeing-sponsored medical plan option other than those listed above, participants should call the member services phone number on their medical plan ID card to verify how the flu shot is covered and if they need to pay at the time they receive their shot. If a claim form needs to be submitted, the participant should ask the pharmacy plan offered under their medical plan option to confirm the claim form submission process.



Question 5: Which retail pharmacies can I go to and receive a flu vaccine at no individual out-of-pocket cost?

Answer: To locate a network Prime Therapeutics network pharmacy, go to myprime.com/boeing and select Find a Pharmacy.

Question 6: Where can employees and covered dependents get a retail flu vaccine? Answer: Health care establishments, including retail pharmacies, may have the vaccine available beginning as early as mid/late August. It is generally recommended by health care providers that people receive the flu vaccine as early as possible after it becomes available.
